**COUNTY OF SAGADAHOC  
PARKING LOT LIGHTING PROJECT**

**BID SHEET**

The undersigned bidder proposes and agrees to the following:

- 1.) The successful bidder has carefully examined the location of the proposed work, the proposed Contract Form (and the Contract Documents therein referred to), and that he/she proposes and agrees, if this Bid is accepted, that he/she will contract with the County of Sagadahoc to provide all machinery, tools, labor, equipment and other means of construction and to do all the work and to furnish all the materials to complete the work in the manner and time therein prescribed, in accordance with the conditions and requirements set forth in the Contract Documents;
- 2.) After notification of the acceptance of the bid and the readiness of the Contract for signature, the successful bidder will execute the contract within ten (10) days, Saturdays, Sundays and holidays excepted, and that the successful bidder will commence work within two (2) weeks of the date of Contract award unless an extension is granted by the County.
- 3.) Any deviations from the specifications included in the bid packet must be explained on the bid sheet.
- 4.) The successful bidder shall furnish a current Certificate of Insurance, naming the County of Sagadahoc as an additional insured, at the time the Contract is executed.
- 5.) The County reserves the right to waive any informalities in proposals, to accept a proposal of section(s) of the proposal, to negotiate a revised scope of services and/or fees, and to reject any or all proposals, or portions thereof, should it be deemed in the best interest of the County to do so. No proposal may be withdrawn for a period of sixty (60) days after the submission deadline. In the event of any doubt or difference of opinion as to the items to be furnished under the request for proposal, the decision of the County shall be final and binding on all parties.
- 6.) All materials and labor required to complete the work, including disposal of any disturbed asphalt, shall be supplied by the Contractor. The cost and expense of all necessary labor, tools, permits and equipment required to complete the project shall be included in the bid price.

7.) The minimum acceptable manufacturer's warranty is five (5). The terms of the warranty offered by the manufacturer of the equipment to be installed by the bidder must be included on the Bid Sheet.

8.) Non-withstanding and/or in addition to any manufacturer's warranty, the Contractor will guarantee all work for a period of two (2) years from the final completion date.

9.) The County shall pay 100% of the contract cost when the work is complete and operational to the satisfaction of the County Administrator.
